## **STUDENT CHROMEBOOK AGREEMENT**

Please sign this agreement to acknowledge that you agree with the rules and policies regarding the use of Chromebooks while away from the school site.

- 1. I understand that the device and any accessories assigned to me at all times remains the property of Happy Valley Union Elementary School District.
- 2. I will never leave the Chromebook unattended.
- 3. I will never loan my Chromebook out to other individuals.
- 4. I will know where my Chromebook is at all times.
- 5. I will charge my Chromebook battery daily.
- 6. I will not change my school-issued Google password unless I am directed to by school personnel.
- 7. I will keep food and beverages away from my Chromebook since they may cause damage to the device.
- 8. I will not disassemble any part of my Chromebook or attempt any repairs.
- 9. I will protect my Chromebook and transport it in either my own backpack or in a case that I will provide.
- 10. I will use my Chromebook in ways that are appropriate, meets HVUESD's expectations, and that are educational.
- 11. I understand that the school-issued device will be monitored using school-issued monitoring applications such as Go Guardian and Securely.
- 12. I will not place decorations (such as stickers, markers, etc.) on the Chromebook.
- 13. I will not remove the serial number label or any HVUESD issued label.
- 14. I will follow the policies outlined in the Student Acceptable Use Policy (signed at the beginning of the school year) while at school, as well as outside the school day and during Distance Learning.
- 15. I will contact my teacher immediately in case of theft, vandalism, breakage, or any other event that disables my Chromebook due to my actions or the actions of another.
- 16. I will be responsible for all damage or loss caused by neglect or abuse.
- 17. I agree to return the Chromebook, and any provided accessories in good working condition, otherwise, I may be asked to compensate the school for the cost of the device.
- 18. I will not use sites that allow access to blocked sites (i.e. social media, or other inappropriate websites).
- 19. I will not be mean to others online and will not support bullying of any kind.
- 20. I understand that HVUESD reserves the right to search the contents of my assigned HVUESD device if there is reasonable suspicion of inappropriate content that is harmful to me or any other user of HVUESD provided technology.
- 21. I understand that my use of the Chromebook is subject to all applicable HVUESD policies and regulations, including but not limited to the HVUESD Student Acceptable Use Policy as well as any applicable provisions of the Student Handbook and any individual school policies and procedures.
