 - Tim Garman praised district staff for the job they have done in getting school started, keeping it going, and complying with all safety measures to keep everyone safe; Ben Swim asked how the water district increase would affect the district, the size of the water meters and could the district downsize if necessary or consolidate; Cheryl Frazer reported that 4H meetings have started and asked about possible facility use; Carla Perry reported that a community member was concerned about the ball field being mowed on a red flag day.
 - e) Primary Site Update Karen Maki reported the following: students and teachers are getting into a routine. Students are quickly learning the expectations to be able to attend school in person; teachers have been reviewing the Emergency Operations Plan; CDS is transitioning three of the five students enrolled in the program.

- f) Elementary Site Update Shelly Craig reported the following: she and Doug O'Brien have been making classroom visits; TRIO has been on campus; discussion is ongoing regarding the implementation of virtual clubs.
- 12.2 Superintendent Update Ms. Herd reported the following: the SPED JPA has hired a psychologist; the district has purchased a portion of time for Amy Barker, Assistant Superintendent of the Mountain Valley Consortium, to write grants for the district; Karen and Shelly are doing a great job getting the schools up and running; the PPE equipment is still coming in; the long-term counselor will be starting tomorrow.
- Business Manager Update Beth Roberts reported the following: the district is discontinuing their service with TDS and switching to a TPX VOIP system. This will save the district approximately \$3000 a month. We are hoping to keep the current phone numbers for the district; she is applying for a TRAN to get through cash flow; the district qualified for a \$405,000 grant to buy an electric bus.
