UNAUDITED ACTUALS SUMMARIZED
September 8, 2020**

This report reflects the actual expense incurred and revenues received for the 2019-2020 school year. The expenses are a reflection of what has been spent in each resource. The revenues have been accrued for the anticipated funding that we will still receive for 2019-2020 and unspent restricted revenues have been deferred.

The beginning fund balance for 2019-2020 was \$1,323,079. The ending balance for 2019-2020 is \$832,209. This represents deficit spending of **\$490,870** – of which, \$349,697 was for the completion of the Bus Barn project – which indicates a truer picture of our deficit spending to be **\$141,173**.

In comparison to the Third Interim Budget, the general fund revenue increased by **\$45,467** and expenses increased **\$17,611**. The revenue increase is mostly due to the receipt of MAA and Medi-Cal Reimbursement funds from prior years, and an increase to the revenue side of the STRS on behalf calculation. The increase in expenditures is the mainly due to the adjustment to the STRS on behalf calculation. Overall we were able to decrease our deficit spending for 2019-20 by \$27,856. The District as a whole is working toward a balanced budget by looking at all areas and being cognizant of all expenses and their necessity.

The Reserve for Economic Uncertainties is \$331,482 and represents a 5% reserve. Program carryover, as well as restricted funds, will be re-budgeted in 2020-2021. The reserves also reflect an additional reserve of \$198,000 for District Economic Uncertainty to assist with cash flow as we go into the 2020-21 budget year facing devastating cash deferrals.

ACTION REQUESTED:

It is recommended that the Board approve the 2019-2020 Unaudited Actuals.

Part IV - Carry-forward Adjustment

The carry-forward adjustment is an after-the-fact adjustment for the difference between indirect costs recoverable using the indirect cost rate approved for use in a given year, and the actual indirect costs incurred in that year. The carry-forward adjustment eliminates the need for LEAs to file amended federal reports when their actual indirect costs vary from the estimated indirect costs on which the approved rate was based.

Where the ratio of indirect costs incurred in the current year is less than the estimated ratio of indirect costs on which the approved rate for use in the current year was based, the carry-forward adjustment is limited by using either the approved rate times current year base costs, or the highest rate actually used to recover costs from any program times current year base costs, if the highest rate used was less than the approved rate.
